BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the offer of DUNLEAVY MARINE PRODUCTS, INC., is hereby accepted; and the City Manager is hereby authorized to execute a contract for the purchase of FIVE (5) PORTABLE FIBERGLASS LIFEGUARD TOWERS at a cost of \$5,500.00 each, for a total cost of \$27,500.00; terms 2% 15 days, plus sales tax.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$13,000.00 of Fund 30245 from CIP 23-606, Beach Comfort Station to CIP 27-004, Ocean Beach Lifeguard Station.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$13,000.00 of Transient Occupancy Tax Fund 81150 from CIP 27-004, Ocean Beach Lifeguard Station to CIP 27-005.1, Lifeguard Towers (Seasonal).
4. That the expenditure of \$38,000.00 from Transient Occupancy Tax Fund 81150, CIP 27-005.1 Lifeguard Towers (Seasonal) of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
