APPROVING MAP OF PARK DE VILLE

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by M. KENT JOHNSON, a Registered Civil Engineer, entitled "PARK DE VILLE Being a subdivision of a portion of Lots 13, 14, 15 and all of Lot 16, Block 241 of University Heights, in the City of San Diego, County of San Diego, State of California, according to the amended map thereof made by G. A. D'Hemecourt in Book 8, Page 36, et seq. of the Lis Pendens, in the office of the Recorder of said San Diego County, together with a portion of the north 15 feet of Pennsylvania Avenue, and the westerly 25 feet of Park Boulevard adjoining the above described portions of said Lots 13, 14, 15 and all of 16 as said streets were vacated and closed to public use respectively on January 5, 1920 by Resolution No. 25145 and August 31, 1914 by Resolution No. 18061 of the Common Council of said City of San Diego.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.
