That the acceptance by the City Manager of that deed of SIMON AARDEMA and ROSA MARTHA AARDEMA, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of October 13, 1980, a copy of which is on file in the office of the City Clerk as Document No. RR- 253214, granting to said City a temporary easement for road purposes and appurtenances thereto, for the purpose of providing ingress to and egress from the adjacent and contiguous lands over Parcel 1 of Parcel Map 1318, being a division of Lots 1 and 2 of Sequoia Pacific Industrial Park, Map 7279, as more particularly described in said deed, for access from Mercury Street to the Miramar Sanitary Landfill, be, and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$46,000.00 from General Services Operational Funds for the Miramar Landfill Program Element 53332 to cover the cost of extending the use of the road for a one-year period, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
