That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with WOODWARD-CLYDE CONSULTANTS, for an amount not to exceed \$15,000, to prepare a subsequent Environmental Impact Report for the Sunset Cliffs Shoreline Protection Project, under the terms and conditions set forth in the First Amendment to Agreement on file in the office of the City Clerk as Document No. RR-253219.

BE IT FURTHER RESOLVED, that the sum of \$15,000 is hereby authorized from bond funds allocated to C.I.P. 13-002 for Fiscal Year 1981, for the sole and exclusive purpose of providing funds for the project.
