BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$45,000 from C.I.P. 27-009.1 Children's Pool Wall Reconstruction to C.I.P. 23-547 Crest Canyon Erosion Control-Phase I.

BE IT FURTHER RESOLVED, that the expenditure of \$25,000 from the Capital Outlay Fund No. 30245, C.I.P. No. 23-547 Crest Canyon Erosion Control-Phase I, of The City of San Diego, be hereby authorized, solely and exclusively, to supplement Resolution R-253042 funding the Construction of Crest Canyon Erosion Control-Phase I Interim Project to provide contingency funds for construction of this project.
