RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO, CALIFORNIA, APPOINTING AND
RETAINING SPECIAL BOND COUNSEL, ENGINEER
OF THE WORK, AND ASSESSMENT ENGINEER
PURSUANT TO SECTION 79 OF CITY CHARTER

WHEREAS, on DEC 8 1980 the Council adopted Reso-
lution No. R-253232, approving a Petition which is on
file in the office of the City Clerk as Document No.

D-022274, for the construction and installation of certain
public improvements as referenced therein, under the pro-
visions of the Improvement Act of 1913; and

WHEREAS, in the Petition the property owners requested
that Richard A. Burt, Esq., of Gray, Cary, Ames & Frye, be
retained as special bond counsel and to perform certain
legal services required for the proceedings; and

WHEREAS, in the Petition the property owners requested
that Bement-Dainwood-Sturgeon be retained to perform the
design engineering and assessment engineering services in
connection with the proceedings; and

WHEREAS, in the Petition the property owners agreed,
pursuant to Section 79 of the Charter of The City of San
Diego, to indemnify and hold The City of San Diego and all

officials, employees, and bodies thereof, free and harmless of and from any and all claims, liability or cost or expense if for any reason the proceedings are abandoned or the assessments are not levied or collected; and

WHEREAS, by letter dated August 1, 1980, on file in the office of the City Clerk as Document No. D-02227-2, Richard A. Burt, of the law firm of Gray, Cary, Ames & Frye, agreed, pursuant to the provisions of Section 79 of the City Charter, to indemnify and hold The City of San Diego and all officials, employees and bodies thereof, free and harmless of and from any and all claims, liability or cost or expense if for any reason the proceedings are abandoned or the assessments are not levied or collected; and

WHEREAS, by letter dated July 7, 1980, on file in the office of the City Clerk as Document No. D-02227-3, Bement-Dainwood-Sturgeon agreed, pursuant to the provisions of Section 79 of the City Charter to indemnify and hold The City of San Diego and all officials, employees and bodies thereof, free and harmless of and from any and all claims, liability or cost or expense if for any reason the proceedings are abandoned or the assessments are not levied or collected; NOW THEREFORE

Burt, dated August 1, 1980, on file in the office of the City Clerk as Document No. D-02227-2

BE IT FURTHER RESOLVED, that Bement-Dainwood-Sturgeon be and the same is hereby retained and appointed as engineer of the work and as assessment engineer for the purpose of performing certain design and assessment engineering services required for the proceedings referenced in the Petition pursuant to the terms and conditions set forth in the letter of Bement-Dainwood-Sturgeon dated July 7, 1980, on file in the office of the City Clerk as Document No. D-02227-3

BE IT FURTHER RESOLVED, that in the event the proceedings are abandoned or the assessments are not levied or collected, The City of San Diego shall not be liable for the payment of any costs or expenses in connection with the employment of Richard A. Burt or Bement-Dainwood-Sturgeon.
