

RESOLUTION NO. R-253267Adopted on DEC 15 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Robert Frajman	General Services	\$ 50	Mr. Frajman is an Electrician. He suggested providing ventilation for emergency generator room during charging of generator batteries at Central Police Station. Although savings can not be calculated, this suggestion was considered to be a significant safety improvement.
Louis Ciardi	Building Inspection	\$ 50	Mr. Ciardi is an Electrical Inspector in the Building Inspection Department. He suggested the issuing of temporary service permits on standard electrical permits instead of having separate forms for each. Although savings could not be calculated, this suggestion was considered to be a significant public service improvement.
Robert E. Wilson	Fire	\$ 50	Mr. Wilson is a Fire Engineer. He suggested modifying Seagrave apparatus to have a readily available air supply for pressurizing water extinguishers using air as the expellant. Although savings could not be calculated, this suggestion was considered to improve the performance of City equipment.
Rick Cumming, III	Risk Management	\$ 35	Mr. Cumming is the Safety Manager in the Risk Management Department. He suggested the use of mounting boards for Suggestion Award Certificates instead of metal and glass frames. This is expected to save the City \$110 a year in labor and material costs.
Conrad Grocholski	Police	\$ 30	Mr. Grocholski is a Property Clerk at Northern Division. He suggested the installation of smoke detectors in the stock room and property room in Northern Division Police Station. Although savings could not be calculated this suggestion is considered to be a significant safety improvement.
