

RESOLUTION NO. R-253268Adopted on DEC 15 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Jennifer Sisskind	Police	\$ 30	Ms. Sisskind is a Junior Clerk. She suggested typing additional information on a citation index card when further arrests are made instead of retyping a new card. Estimated annual savings to the City is \$95 in labor and material.
Richard Boles	General Services	\$ 30	Mr. Boles is an Airport Operations Assistant. He suggested posting No Smoking and No Traspassing signs in Spanish at the Brown Field Airport aviation fuel storage area. Although savings could not be calculated, this suggestion was considered to be a significant safety improvement.
Alvus L. Ramsay	Fire	\$ 30	Mr. Ramsay is a Fire Engineer. He suggested mounting a spotlight over the top equipment well and place a steel plate over the controls. Although savings could not be calculated, this suggestion was considered to improve safety and equipment efficiency.
Davis Darnell	General Services	\$ 30	Mr. Darnell is a Sanitation Supervisor. He suggested putting a platform on the front of spray rigs to reduce the chance of operators getting injured. Although savings could not be calculated, this suggestion was considered to be a significant safety improvement.
Charles Kinne1	Fire	\$ 25	Mr. Kinne1 was a Fire Engineer. He suggested the use of a plate and chain to separate the ladders and make them more easily accessible on fire apparatus. Although savings could not be calculated, this suggestion was considered to be a significant improvement in the performance of City equipment.
