James R. Lee	Fire	\$ 25	Mr. Lee is a Fire Engineer. He suggested an accountability method for conducting breathing apparatus tests that are uniform for all stations and divisions. Although savings could not be calculated, this suggestion was considered to be a significant improvement in efficiency.
Michael B. Strang	Fire	\$ 25	Mr. Strang is a Firefighter. He suggested relocating the hose rewind button on fire apparatus to protect the equipment. Although savings could not be calculated, this suggestion was considered to be a significant improvement in the performance of City equipment.
Barbara Butler	Police	\$ 20	Ms. Butler is an Intermediate Typist. She suggested that additional information be placed on Vehicle Reports. Although savings could not be calculated, this suggestion was considered to be an improvement in efficiency.
Thomas Simonds	Police	\$ 20	Mr. Simonds is a Police Motorcycle Officer. He suggested that a safety chain be placed on the sign holder on Stadium parking signs. Although savings could not be calculated, this suggestion was considered to be a significant safety improvement.
Kevin Dubler	Fire	\$ 20	Mr. Dubler is a Firefighter. He suggested the distribution of a bulletin to supervisors regarding the method for applying AFFF foam. Although savings could not be calculated, this suggestion was considered to be an improvement in efficiency.
