BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by JAMES H. ALGERT, a Registered Civil Engineer, entitled
"AVERIL VILLA Being a subdivision of a portion of the
Southwest Quarter of the Southeast Quarter of Section 35,
Township 18 South, Range 2 West, San Bernardino Base and
Meridian, in the City of San Diego, County of San Diego, State
of California, according to United States Government Survey,
approved February 25, 1870.," is made in the manner and form
prescribed by law and conforms to the surrounding surveys;
that said map and the subdivision of land shown thereon is
hereby approved and accepted; and said Council hereby accepts
on behalf of the public a portion of Averil Road for public
purposes; and said portion of a street is hereby declared to
be a portion of a public street and dedicated to the public
use.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map and that
said portion of a public street is accepted on behalf of the
public as heretofore stated.
