1. That the bid of \$297,200.00 by DYNO CONSTRUCTION, INC., a corporation, for the CONSTRUCTION OF ALCOTT NEIGHBORHOOD PARK-INITIAL DEVELOPMENT, Base Bid and Deductive Alternate 1 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the office of the City Clerk as Document No. A-00136.
2. That the City Auditor and Comptroller is hereby authorized to increase CIP 23-028, Alcott Neighborhood Park by \$70,067.00.
3. That the expenditure of \$38,171.00 from PSD 13221, \$18,583.00 from PSD 13440, \$4,417.00 from PSD 13410 and \$3,896.00 from PSD 13481 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
