1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-253318-1, quitclaiming to H.G.H. & E. NO. 2, a limited partnership, all the City's right, title and interest in the drain easement, as more particularly described in said quitclaim deed.
