That the Project Economics and Financing and Ownership reports prepared by Merrill Lynch White Weld Capital Markets Group are hereby approved in concept and the consultant is hereby directed to further develop the recommended alternative.

BE IT FURTHER RESOLVED, that for purposes of preparing a project Environmental Impact Report, the following sites are designated:

Preferred Site--the City-owned (ex-sewage treatment plant) site on Harbor Drive.

(Site 2)--either of two Navy sites at the intersection of Harbor Drive and 8th Street in National City.

(Site 3) -- that portion of the Naval Station currently being used as a golf course (at intersection of Wabash and Main Street).

BE IT FURTHER RESOLVED, that the expenditure of \$185,000 is hereby authorized from the Unallocated Reserve as the City's share of a technical/management consultant for the SANDER project, and authorizing the City Manager to execute an agreement with the County of San Diego for the transfer of these funds for the sole purpose of retaining the Mitre Corporation as a SANDER project technical/management consultant.
