WHEREAS, the City Council on October 28, 1980 adopted Ordinance No. O-15375 (New Series) entitled, "AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, APPROVING THAT CERTAIN LEASE AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO OF CERTAIN PROPERTY LOCATED IN THE COLUMBIA REDEVELOPMENT PROJECT FOR THE PURPOSE OF CONSTRUCTION AND OPERATION OF A CONVENTION AND EXHIBITION CENTER"; and

WHEREAS, on November 26, 1980 a Referendary Petition requesting the City Council to repeal or rescind Ordinance No. O-15375 (New Series) or submit said ordinance to the registered voters of the City for their approval or rejection was filed in the Office of the City Clerk; and

WHEREAS, the City Clerk has found the Referendary Petition to contain the requisite number of valid signatures and to be in proper form and has so certified, and has presented the petition with his certification attached to the City Council on December 16, 1980; and

WHEREAS, pursuant to San Diego Municipal Code Sections 27.2615 and 27.2616, the City Council must within ten (10) days reconsider the legislative act in question and if the Council refuses to grant the petition to repeal the legislative act in question or fails to reconsider the act within ten (10) days after presentation by the Clerk, the Council

shall forthwith adopt a resolution of intention to submit the matter to the people at a special election or any other election or elections at which all the voters are entitled to vote to be held within eleven (11) months from the date the Referendary Petition is presented to the Council; and

WHEREAS, the Council does not intend to grant the petition to repeal the legislative act and does not intend to reconsider the act within ten (10) days after presentation by the Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council intends to submit the matter to the people at a special election or any other election to be held within eleven (11) months from December 16, 1980, the date the Referendary Petition has been presented to the Council by the City Clerk.
