BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by ROBERT W. SANFORD, a Registered Civil Engineer, entitled "GREY DOVE Being a subdivision of Villa Lot 2 of Palm Heights, according to Map thereof No. 1023, filed in the office of the County Recorder of San Diego County, January 10, 1907; and Lot 19 of Whitney Park according to Map thereof No. 4419, filed in the office of the County Recorder of San Diego County, December 16, 1959, in the City of San Diego, County of San Diego, State of California.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for general utility purposes over, under, upon and across portions of Lots 4, 5 and 7, as granted and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the open space easement over, under, upon and across Lots 1 through 4 and Lot 7, as granted and shown on said map and subject to the conditions set forth thereon.
