ORDINANCE NO. O-15413 (New Series)

AN ORDINANCE AMENDING CHAPTER III, ARTICLE 3, DIVISION 35, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 33.3506.1 AND AMENDING SECTION 33.3516, RELATING TO THE REGULATION OF MASSAGE ESTABLISHMENTS AND MASSAGE TECHNICIANS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter III, Article 3, Division 35, of the San Diego Municipal Code be and the same is hereby amended by adding Section 33.3506.1 and amending Section 33.3516, to read as follows:

SEC. 33.3506.1 MASSAGE ESTABLISHMENT LICENSE--HEALTH DEPARTMENT INSPECTION AND INVESTIGATION

In addition to the requirements of Section 33.3506, any person, association, partnership, or corporation desiring to operate a massage establishment shall make an application to the County of San Diego, Department of Health Services, for a Health Permit. An annual nonrefundable fee, the exact amount of which shall be determined and kept on record by the County Department of Health Services, shall accompany the submission of each application to the Department of Health Services to defray the cost of investigation, inspection and enforcement of the health aspects of this Division.

Any massage establishment licensee failing to renew the Health Permit within thirty (30) days after

expiration shall be assessed a ten percent (10%) penalty for each month of failure to renew added to the cost of the renewal of the Health Permit fee, and this sum shall be paid to the Department of Health Services. In no case shall the penalty exceed sixty percent (60%) of the renewal fee. The imposition and/or payment of the penalty imposed by this Section shall not prevent the imposition of any other penalties prescribed by this Chapter or prosecution for violation of this Chapter. SEC. 33.3516 CHANGE OF LOCATION

A change of location of a licensed massage establishment shall be approved by the Chief of Police provided all applicable provisions of this Division are complied with, the San Diego County Department of Health Services and the Department of Building Inspection have inspected the new location and have advised the Chief of Police that it complies with the requirements of this Division and all other applicable laws, a nonrefundable Health Permit fee has been paid to the County of San Diego for inspection of the new location, and a nonrefundable change of location fee has been paid to the Chief of Police. The Chief of Police shall not approve any change of location until the massage establishment licensee has complied with all applicable provisions of this Division and all other applicable laws.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
