AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 3, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 63.03 RELATING TO PERMIT FEES

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Chapter VI, Article 3 of the San Diego Municipal Code be amended by amending Section 63.03 to read as follows:

SEC. 63.03 MUNICIPAL RECREATION FACILITIES - USE WITHOUT AUTHORIZATION UNLAWFUL

It shall be unlawful for any person to make use of any municipal recreation facility for which an activity fee, ticket or permit has been established by resolution of the City Council without first having obtained the required permit or ticket or paid the required fee authorizing such use.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
