It shall be unlawful to operate a paratransit vehicle unless there shall be filed with the City of San Diego, a policy of insurance executed and delivered by a company authorized to carry on an insurance business in the State of California, the financial responsibility of which company shall theretofore have been

approved by the City Manager, by the terms of which said insurance company assumes responsibility for injuries to persons or property caused by the operation of said vehicle in an amount determined by the City Manager and filed with the City Manager or his designated representative. A permit holder may obtain a certificate of self-insurance for a specified amount approved by Council pursuant to the applicable provisions of the California Vehicle Code.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
