AN ORDINANCE AMENDING ORDINANCE NO. 15298 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENTS NO. 00-15298-1 AND 00-15298-2, AS ADOPTED AND AMENDED THEREIN, BY ADDING 0.50 SENIOR LIBRARIAN AND 0.50 INTERMEDIATE TYPIST TO THE LIBRARY DEPARTMENT; AND TRANSFERRING \$19,649 FROM UNALLOCATED RESERVE TO THE LIBRARY DEPARTMENT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 15298 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Documents 00-15298-1 and 00-15298-2, as adopted and amended therein, by adding 0.50 Senior Librarian and 0.50 Intermediate Typist to the Library Department.

Section 2. That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$19,649 from the Unallocated Reserve to the Library Department to provide the funding for the Library Department Volunteer Coordinator function.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
