AN ORDINANCE AMENDING ORDINANCE NO. 15298 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED BY EXEMPTING FROM THE CLASSIFIED SERVICE FIVE PRINCIPAL PLANNER POSITIONS (PROGRAMS 06530, 06540 AND 06560) AND ONE ASSISTANT TO THE PLANNING DIRECTOR POSITION (PROGRAM 06520).

WHEREAS, there are five Principal Planners allocated to the Planning Department and one Assistant to the Planning Director; and

WHEREAS, Section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission has reviewed this request on November 24, 1980, and commented favorably upon the exemption of the five Principal Planners and unfavorably on the exemption of the Assistant to the Planning Director; and

WHEREAS, a review of these six positions (as enumerated hereinafter) indicates the nature and duties of these six positions are consistent with the unclassified criteria set forth in Charter Section 117(a)17; and

WHEREAS, it is now requested that those positions be exempted from the Classified Service pursuant to the Charter provisions; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said exemption; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That pursuant to Section 117(a)17 of the City
Charter, after having been reviewed and commented upon favorably
by the Civil Service Commission on November 24, 1980, the
following Principal Planner and Assistant to the Planning Director
positions are hereby exempted from the Classified Service and
declared to be in the Unclassified Service of The City of San
Diego:

Section 2. That Ordinance No. 15298 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-15298-1, as adopted

and amended therein, by reflecting said exemptions within the personnel authorization schedule of Department 06500.

Section 3. As a schedule of compensation for the unclassified positions of Principal Planner created in Section 1 hereof, the salary rate set forth in Salary Rate 7.5 of the Table of Classifications and Standard Salary Rates under Managerial Category, identified as Exhibit C to Ordinance No. 15268 (New Series), be and the same is hereby adopted.

Section 4. As a schedule of compensation for the unclassified position of Assistant to the Planning Director created in Section 1 hereof, the salary rate set forth in Salary Rate 7.5 of the Table of Classifications and Standard Salary Rates under Managerial Category, identified as Exhibit C to Ordinance No. 15268 (New Series), be and the same is hereby adopted.

Section 5. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
