AN ORDINANCE INCORPORATING LOTS 37 THROUGH 42, BLOCK 54, CITY HEIGHTS, MAP NO. 1007 (APPROXIMATELY .49 ACRES), LOCATED ON THE WEST SIDE OF 40TH STREET BETWEEN UNIVERSITY AVENUE AND WIGHTMAN STREET, IN THE MID-CITY DEVELOPMENT PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 11563 (NEW SERIES), ADOPTED APRIL 17, 1975, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 37 through 42, Block 54, City Heights, Map No. 1007 (approximately .49 acres), located on the west side of 40th Street between University Avenue and Wightman Street, in the Mid-City Development Plan Area, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-3369, be, and it is hereby incorporated into CO Zone, as such zone is described and defined by Section 101.0423 of the San Diego Municipal Code.

Section 2. That Ordinance No. 11563 (New Series), adopted April 17, 1975, of the ordinances of The City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
