AN ORDINANCE AMENDING ORDINANCE NO. 15405 (NEW SERIES), FEB 2 1981 WHICH AMENDED ORDINANCE NO. 15298 (NEW SERIES) ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED, BY EXEMPTING FROM THE CLASSIFIED SERVICE COUNCIL REPRESENTATIVE POSITIONS IN CITY COUNCIL DEPARTMENTS 02300, 02400, and 02800.

WHEREAS, Ordinance No. 15405 (New Series) adopted by City
Council on December 9, 1980, amended the Annual Appropriation
Ordinance to effect the exemption from the Classified Service
of certain Council Representative positions in Council Districts 3,
4 and 8; and

WHEREAS, said Ordinance No. 15405 (New Series) contained the proper exemption declaration in the recitals thereto by declaring the positions to be both Council Representatives I and II; and

WHEREAS, in promulgating said Ordinance, the classification of Counc: Representative I was inadvertantly omitted from Section 1 thereof because of typographical omission; and

WHEREAS, this ordinance is intented to act as a correction thereto and be of no other effect; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 15405 (New Series) adopted by Council on December 9, 1980, amending Ordinance No. 15298 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET

FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," is hereby amended by correcting Section 1 thereof to read as follows:

Section 1. That pursuant to Section 117(a) of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on November 24, 1980, the following Council Representative I and II positions are hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Council District 3 - One (1) Council Representative II

Council District 4 - Three (3) Council Representatives I

Council District 8 - One (1) Council Representative I

Section 2. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
