AN ORDINANCE INCORPORATING A PORTION OF A PARTITION OF PUEBLO LOT 219, MAP NO. 841 AND A PORTION OF LOT 47, BAY CREST, MAP NO. 5334, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 31 (NEW SERIES), ADOPTED SEPTEMBER 6, 1932 AND ORDINANCE NO. 8717 (NEW SERIES), ADOPTED AUGUST 30, 1962, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of a partition of Pueblo Lot 219, Map No. 841 and a portion of Lot 47, Bay Crest, Map No. 5334, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. B-3045, be and it is hereby incorporated into R-3 Zone, as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 31 (New Series), adopted September 6, 1932 and Ordinance No. 8717 (New Series), adopted August 30, 1962, of the ordinances of The City of San Diego be and the same are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage,

and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefo: was made prior to the date of adoption of this ordinance.
