AN ORDINANCE AMENDING ORDINANCE NO. 15298 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED AND ADOPTED THEREIN, BY ESTABLISHING A NEW PROGRAM NUMBER 10355, ENTITLED "POLICE DECENTRALIZATION PROJECT"; AUTHORIZING THE AUDITOR AND COMPTROLLER TO ESTABLISH A NEW FUND, NUMBER 10355, ENTITLED POLICE DECENTRALIZATION PROJECT FUND; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$156,901 FROM THE POLICE DEPARTMENT (GENERAL FUND 100) OPERATING BUDGET TO THE DECENTRALIZATION PROJECT FUND (10355).

WHEREAS, the Fiscal Year 1981 Police Department operating budget contains \$353,768 to cover costs of police decentralization that are ineligible for inclusion in the Capital Improvement Program; and

WHEREAS, it was the intent of the City Council that these funds were to be used for no purpose other than the Police Decentralization Project; and

WHEREAS, it is necessary and desirable to establish a separate fund for such funds so that the monies allocated for the Project are isolated for Project use and not closed out automatically at the end of the fiscal year; and

WHEREAS, this action may be effected by the establishment of a fund separate from the General Fund and the transfer of the appropriated monies to that newly established fund; and

WHEREAS, this action will also provide an effective management tool to staff to allow for improved monitoring capability and control over expenditure of these special purpose funds; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 15298 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" be and the same is hereby further amended by amending Document No. 00-15298-1, as adopted and amended therein, by establishing a new program, number 10355, entitled Police Decentralization Project.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to establish a new Fund, number 10355, to be entitled Police Decentralization Project Fund for the purpose of allocation of funds for said Project.

Section 3. That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$156,901 from the General Fund 100, Police Department Operating Budget to the newly established Police Decentralization Project Fund 10355 for the sole and exclusive purpose of accomplishing Project purposes, said transfer of funds to be in accordance with Attachment A hereto, entitled "Proposed Police Decentralization Program."

Section 4. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings

pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
