AN ORDINANCE TO EXTEND AN EMERGENCY ORDINANCE TO PROHIBIT "RESIDENTIAL CONSTRUCTION ON THE CA-ZONED PROPERTY IN THE AREA BOUNDED ON THE NORTH BY IMPERIAL AVENUE, ON THE WEST BY 61ST STREET, ON THE EAST BY 62ND STREET AND THE CITY LIMITS ON THE SOUTH, IN THE SOUTHEAST COMMUNITY PLAN, AND ALSO THAT CA-ZONED PROPERTY WITHIN THE SOUTH BAY TERRACES SKYLINE/PARADISE HILLS PLANNING AREA FOR A PERIOD ENDING APRIL 15, 1981, TO JULY 15, 1981.

WHEREAS, on December 16, 1980, the City Council adopted an emergency ordinance to prohibit residential construction on the CA-Zoned property in the area bounded on the north by Imperial Avenue, on the west by 61st Street, on the east by 62nd Street and the City limits on the south, in the Southeast Community Plan, and also that CA-Zoned property within the South Bay Terraces Skyline/Paradise Hills Planning Area for a period ending April 15, 1981; and

WHEREAS, it is necessary and desirable to extend the effective period of the ordinance to July 15, 1981 in order to complete studies necessary for potential new zoning for the area; NOW.

THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the effective period of Ordinance
No.0-15407, adopted December 16, 1980, is hereby extended through
the period ending July 15, 1981.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
