AN ORDINANCE AMENDING ORDINANCE NO. 15298 (NEW SERIES) ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED AND ADOPTED THEREIN, BY TRANSFERRING THE SUM OF \$26,000 FROM PRIOR YEAR ENCUMBRANCES, OBJECT ACCOUNT 4222, JOB ORDER 004550, DEPARTMENT 045, PROGRAM 105, TO CURRENT YEAR 1980-81 APPROPRIATION, DEPARTMENT 045, PROGRAM 105, OBJECT ACCOUNT 4222, FOR MATERIALS AND SERVICES RELATING TO RENOVATION FOR JURIS OPERATIONS. MAR 16 1981

WHEREAS, in fiscal year 1979-80, the City of San Diego adopted the computerized criminal information and retrieval system called JURIS; and

WHEREAS, in respect thereto, Council appropriated the sum of \$45,000 in the City Attorney's budget for fiscal year 1979-80 to accommodate the installation of JURIS and the accompanying space renovation; and

WHEREAS, to accomplish the renovation, it was necessary to obtain the services of a City project officer to oversee the work required in connection therewith; and

WHEREAS, it was further necessary to purchase the appropriate materials required in the renovation of facilities; and

WHEREAS, at the end of fiscal year 1979-80, there remained the sum of \$26,000 uncommitted to materials or services due to the absence of a project officer; and

WHEREAS, that sum was thereafter encumbered for the purpose authorized by Council so that it would be available for the materials and services; and

WHEREAS, the Auditor now advises that said sum of \$26,000 cannot be reached at this time since it was not legally owed or committed as of June 30, 1980; and

WHEREAS, in order to accomplish the purpose intended by Council when appropriating said funds, it is now necessary to reappropriate for the current fiscal year 1980-81 that sum which is set aside in prior year's encumbrance; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 15298 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-15298-1, as adopted and amended therein, by transferring the sum of \$26,000 from prior year encumbrances in Department 045, Program 105, Job Order 004550, Object Account 4222 and reappropriating and adding said \$26,000 to the current fiscal year (1980-81) authorization in Department 045, Program 105, Object Account 4222 for the purpose of defraying material and service expenses associated with the renovation of facilities for JURIS operations.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to effect the necessary transfer and reappropriation of the sum of \$26,000 as set forth in Section 1 above.

Section 3. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings

pursuant to the authority contained in Sections 16, 17 and 71
of the Charter of The City of San Diego.



AN ORDINANCE AMENDING ORDINANCE NO. 15298 (NEW SERIES), ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED AND ADOPTED THEREIN, BY TRANSFERRING THE SUM OF \$28,000 FROM PRIOR YEAR ENCUMBRANCES, OBJECT ACCOUNT 4222, JOB ORDER 004550, DEPARTMENT 045, PROGRAM 105, TO CURRENT YEAR 1980-81 APPROPRIATION, DEPARTMENT 045, PROGRAM 105, OBJECT ACCOUNT 4222, FOR MATERIALS AND SERVICES RELATING TO RENOVATION FOR JURIS OPERATIONS.

This ordinance amends the annual appropriation ordinance by transferring to current year (FY 81) appropriation for the City Attorney's department (045) the sum of \$28,000 previously appropriated by Council in fiscal year 1979-80 and encumbered on June 30, 1980. Said funds were authorized by Council for renovation of Criminal Division facilities to accommodate JURIS operations and are intended to be used for the same purpose.
