AN ORDINANCE AUTHORIZING DESIGNATED EMPLOYEES OF THE GITY OF SAN DIEGO TO EXERCISE THE POWERS OF ARREST PURSUANT TO PENAL CODE SECTION 836.5

WHEREAS, certain employees of the City of San Diego, namely the Sanitation Enforcement Supervisor, Supervising Sanitation Inspector, Sanitation Inspectors, and Disposal Fee Collectors, are charged with the responsibility for enforcing certain statutes and provisions of the San Diego Municipal Code dealing with waste disposal; and

WHEREAS, said personnel must currently utilize the formal complaint procedure to initiate criminal proceedings against suspected violators of these Municipal Code provisions; and

WHEREAS, said formal complaint procedures are time consuming, create a substantial administrative burden, and hinder the speedy prosecution of suspected violators; and

WHEREAS, Penal Code Section 836.5 empowers the City Council to authorize the above-named employees to arrest a person without a warrant whenever such employee has reasonable cause to believe that the person to be arrested has committed an infraction or misdemeanor in such employee's presence which is a violation of statute or ordinance which such employee has the duty to enforce; and

WHEREAS, authorizing such City employees to arrest suspected violators of certain statutes or Municipal Code provisions will facilitate the enforcement of the statutes and Municipal Code provisions; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows: Section 1. That the Sanitation Enforcement Supervisor, Supervising Sanitation Inspector, and Sanitation Inspectors are hereby authorized and empowered pursuant to Penal Code Section 836.5 to arrest any person without a warrant whenever said employee has reasonable cause to believe that the person to be arrested has committed an infraction or misdemeanor in said employee's presence which is a violation of any section of Chapter IV, Article 4, Division 1 of the San Diego Municipal Code or Section 374 of the California Penal Code, said employees being charged with responsibility for enforcing the provisions of such Divisions and Section.

Section 2. That the Disposal Fee Collectors are hereby authorized and empowered pursuant to Penal Code Section 836.5 to arrest any person without a warrant whenever said employee has reasonable cause to believe that the person to be arrested has committed an infraction or misdemeanor in said employee's presence which is a violation of Section 44.0121 of the Municipal Code or Section 23115 of the California Vehicle Code, which Sections they are charged to enforce.

Section 3. No employee holding any of the positions listed in Sections 1 and 2 may exercise the power to arrest authorized by Sections 1 and 2 hereinabove unless such employee shall have first completed a course of training in the exercise of his powers of arrest, which course shall meet the minimum standards prescribed by the Commission on Peace Officer Standards and Training for Penal Code Section 832(a) courses.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

Section 5. This ordinance shall not be codified.
