ORDINANCE NO. O - 15478 (New Series)

Adopted on APR 6 1981

An Ordinance Incorporating Lot 2, Bay Ridge, Map 9684 and a Portion of Parcel 1, Parcel Map 4005 (Approximately 1.678 Acres), Located on the West Side of Cowley Way Between Field and Iroquois Streets, in the Clairement Mesa Community Plan Area, in the City of San Diego, California, Into R-3 Zone, as Defined by Section 101.0411 of the San Diego Municipal Code, and Repealing Ordinance No. 11216 (New Series) of the Ordinances of The City of San Diego Insofar As the Same Conflicts Herewith.

BE IT ORDAINED, by the Council of The City of San Diego, as follows: Section 1. That Lot 2, Bay Ridge, Map 9684 and a portion of Parcel 1, Parcel Map 4005 (approximately 1.678 acres), located on the west side of Cowley Way between Field and Iroquois Streets in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. B-3382.1, be, and it is hereby incorporated into R-3 Zone, as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 11216 (New Series), adopted January 17, 1974 of the ordinances of The City of San Diego be, and it is hereby repealed insofar as 1t conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
