## ORDINANCE NO. O 15479 (New Series)

AN ORDINANCE AMENDING CHAPTER V, ARTICLE 2.5 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 52.5.0109 RELATING TO CONSUMER COM-MODITIES PRICE MARKING, TERMINATION OF ARTICLE.

WHEREAS, the City Council of The City of San Diego adopted Ordinance No. O-15235 on April 7, 1980 to add to Chapter V of the San Diego Municipal Code a new Article 2.5 encompassing Sections 52.5.0101 through 52.5.0109; and

WHEREAS, said code sections related to and were entitled, "Consumer Commodities Price Marking"; and

WHEREAS, Section 52.5.0109 provided for a one-year termination date after implementation of the provisions unless the City Council acted affirmatively to extend the provisions of the Article; and

WHEREAS, it is now deemed necessary and desirable to extend the termination date for an additional year so that the purpose and intent, as set forth in Section 52.5.0101, may be achieved; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article 2.5 of the San Diego Municipal Code be and the same is hereby amended by amending Section 52.5.0109 to read as follows:

SEC. 52.5.0109 TERMINATION OF ARTICLE.

The provisions of this Article shall terminate and be of no further force and effect after two years from the effective date of implementation unless the City Council acts affirmatively thereupon to extend its provisions.

Section 2. All other provisions of Chapter V, Article
2.5 of the San Diego Municipal Code, to wit, Sections 52.5.0101
through 52.5.0108 shall remain unchanged and continue in
full force and effect.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
