- (b) Provided, however, that in no event shall the foregoing service area descriptions exclude from this franchise ordinance any area now served by Grantee and inadvertently omitted due to inaccuracies or oversight in said service area description.

Section 2. All other provisions of Ordinance No. 12543 remain in full force and effect.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
