BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Chapter II, Article 7, Division 21  
of the San Diego Municipal Code be and it is hereby amended  
by amending Section 27.2102, to read as follows:

SEC. 27.2102 PERSONAL APPEARANCE OF CANDIDATES

Candidates seeking nomination either by election  
or appointment shall appear personally before the  
Clerk to sign the nominating petition unless service  
with the United States Armed Forces or a physical  
disability prevents such an appearance.

Section 2. This ordinance shall take effect and be in  
force on the thirtieth day from and after its passage.
