AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 7
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING
SECTION 67.61 RELATING TO WATER RATES.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter VI, Article 7 of the San Diego
Municipal Code be and it is hereby amended by amending Section
67.61 to read as follows:

SEC. WATER RATES--SERVICE TO CITY OF SAN DIEGO

The rates for water and water service supplied to
the various Departments of The City of San Diego shall
be the same as those rates in effect for all other
Consumers WITHIN the City, as in this Article specified,
and the water and water service so furnished shall be
charged to their respective budget accounts and paid for
annually from such funds into the fund provided by
charter for the receipts from sale of water.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.
