AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6, DIVISION 20 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 86.23 RELATING TO PARKING VEHICLES FOR SALE OR SERVICE PROHIBITED.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 6, Division 20 of the San Diego Municipal Code is hereby amended by amending Section 86.23 to read as follows:

SEC. 86.23 PARKING VEHICLES FOR SALE OR SERVICE PROHIBITED.

- (a), (b), (c) and (d) No change.
- (e) No person whose business involves the repair and/or servicing of vehicles and/or vehicle components shall store, stand or park any vehicle upon any public street after that person has accepted custody of the vehicle from the customer.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
