AN ORDINANCE AMENDING ORDINANCE NO. 15268 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1980-81" BY AMENDING EXHIBIT C THERETO TO CREATE THE NEW CLASS OF ASSISTANT ZONING ADMINISTRATOR AND ESTABLISHING A SCHEDULE OF COMPENSATION THEREFOR.

WHEREAS, the Civil Service Commission, at its regularly scheduled meeting of March 5, 1981, considered and approved the creation of the new classification of Assistant Zoning Administrator in the service of The City of San Diego; and

WHEREAS, the Commission at that same March 5, 1981, meeting also reviewed and commented favorably, pursuant to Charter Section 117(a)17, for the exemption of said classification from the Classified Service of The City of San Diego; and

WHEREAS, the Planning Director is recommending that the classification be placed at Salary Rate 7.5.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 15268 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1980-81" be and the same is hereby further amended by amending Exhibit C thereto to create and establish the classification of Assistant Zoning Administrator in the Managerial ranks.

Section 2. That pursuant to Section 117(a)17 of the City Charter, the Civil Service Commission, after reviewing said position and commenting upon it favorably, hereby approves and forwards to the City Council for final approval exemption from the Classified Service for said position.

Section 3. As a schedule of compensation for the position created in Section 1 above, the salary rate number of 7.5 of the Base Salary Table is hereby approved and assigned said position.

Section 4. The position of Assistant Zoning Administrator shall be inserted in the Classification Range of Managerial C contained in Exhibit C with Salary Rate 7.5 attached.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


