An Ordinance Incorporating a Portion of Lot 1, Juegos De Juan Racquet Club, Map No. 8393 (approximately 1.10 acres), Located on the West Side of Waring Road between I-8 and Adobe Falls Road, in the Navajo Community Plan Area, in the City of San Diego, California, into CO Zone, as Defined by Section 101.0423 of the San Diego Municipal Code, and Repealing Ordinances No. 11116 (New Series), adopted September 6, 1973, and No. 11462 (New Series), adopted December 26, 1974, of the Ordinances of The City of San Diego Insofar as the Same Conflict Herewith.

BE IT ORDAINED, by the Council of The City of San Diego, as follows: Section 1. That a portion of Lot 1, Juegos De Juan Racquet Club, Map No. 8393, (approximately 1.10 acres), located on the west side of Waring Road between I-8 and Adobe Falls Road, in the Navajo Community Plan area, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-3411, be, and it is hereby incorporated into CO Zone, as such zone is described and defined by Section 101.0423 of the San Diego Municipal Code.

Section 2. That Ordinances No. 11116 (New Series), adopted September 6, 1973, and No. 11462 (New Series), adopted December 26, 1974, of the ordinances of The City of San Diego be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
