

ORDINANCE NUMBER O- 15524 (New Series)

Adopted on JUN 15 1981

An Ordinance Incorporating Lots 806, 807 and 808, Bay Terraces Unit 8, Map 6971 (Approximately 23.03 Acres), in the South Bay Terraces Development Area in the City of San Diego, California, into "CA-RR" Zone, as Defined by Section 101.0427.1 of the San Diego Municipal Code, and Repealing Ordinance No. 9957, (New Series), Adopted January 30, 1969 of the Ordinances of The City of San Diego Insofar as the Same Conflicts Herewith.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 806, 807 and 808, Bay Terraces Unit 8, Map 6971 (approximately 23.03 acres) in the South Bay Terraces Development area in the City of San Diego, California, within the boundary of the district designated "CA-RR" on Zone Map Drawing No. B-3397.1, be, and it is hereby incorporated into CA-RR Zone, as such zone is described and defined by Section 101.0427.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. O-9957, adopted January 1, 1981, of the ordinances of The City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
