An Ordinance Amending Ordinance No. O-15298 (New Series), Entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" by Amending Documents No. OO-15298-1 and No. OO-15298-2, as Amended and Adopted Therein, by Transferring the Sum of \$22,000 from the General Fund 100, Unallocated Reserve (605) to the Extradition Travel Fund (81110) for the Purpose of Augmenting Said Fund.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-15298 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-15298-1 and No. OO-15298-2, as amended and adopted therein, by transferring the sum of \$22,000 from the General Fund 100, Unallocated Reserve (605) to the Extradition Travel Fund (81110) for the purpose of providing additional funds to pay for extradition of criminal suspects prior to State of California reimbursement of out-of-pocket expenses incurred by the City.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of the City of San Diego.


