BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-15298 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-15298-1 and No. OO-15298-2, as amended and adopted therein, by transferring the sum of \$8,750 from the General Fund 100, Unallocated Reserve (605) to the Central Stores Revolving Fund (50010) for the purpose of reimbursing the fund for purchase of shelving for the 12th floor conference room.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of the City of San Diego.


