Section 1. That Ordinance No. 15298 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Documents No. 00-15298-1 and No. 00-15298-2, as adopted and amended therein, by appropriating and transferring the sum of \$890,000 from Unappropriated Revenue to Water Revenue Fund 41502 for Capital Improvement Project CIP 73-083, Water Main Replacement Group 429.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.


