AN ORDINANCE AMENDING ORDINANCE NO. 15510 (NEW SERIES) ENTITLED, "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1981-82," BY AMENDING SECTION 13 THEREOF.

WHEREAS, the Annual Salary Ordinance provides in Section 13 for recognition of outstanding performances by employees and payment of an award therefor; and

WHEREAS, said provision provides only for a one-time award in the maximum amount of \$1,000 but does not provide for such recognition on successive projects during any given year; and

WHEREAS, it is desirable to amend such provision to so provide, maintaining however the maximum award limit for any given year; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Ordinance No. 15510 (New Series) entitled "AN ORDINANCE
ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY

OF SAN DIEGO FOR THE FISCAL YEAR 1981-82," be and the same is hereby amended to

to read as follows:

Section 13. EXCEPTIONAL PERFORMANCE COMPENSATION.

The City Council hereby authorizes the City Manager to establish and implement an Exceptional Performance Compensation Program. Such program shall include criteria under which employee performance shall be evaluated. Those employees judged to be exceptional performers may be granted one or successive performance payments in an amount not to exceed a total of one thousand dollars (\$1,000) in any one fiscal year. PAGE 1 OF 2

Such payments shall not be considered to be a part of an employee's base compensation for any purpose, except as provided in Section 5 of this ordinance, nor shall such employee acquire any right to receive future exceptional performance payments.

Section 2. This Ordinance shall take effect and be in force on the thirtieth day from and after its passage.
