## ORDINANCE NUMBER 0- 15584 (New Series) Adopted on SEP 14 1981

An Ordinance Amending Section 1 of Ordinance No. O-11569 (New Series), Adopted April 24, 1975, Amended by Ordinance No. 12105 (New Series), Adopted July 20, 1977, and Amended by Ordinance No. 12690 (New Series), Adopted July 9, 1979, Incorporating Lot 2, Ocheltree Subdivision, Resubdivision of Lot 15; Portions of Lots 12 and 13, Ocheltree Subdivision Unit 1; and a Portion of Section 27, Township 18 South, Range 2 West, SBBM; and a Portion of Outer Road to be Vacated, in the City of San Diego, California, into CR Zone, as Defined by Section 101.0421.1 of the San Diego Municipal Code.

WHEREAS, a request has been received to extend the time on Ordinance No. 0-11569 (New Series), adopted April 24, 1975; and

WHEREAS, Section 1 of Ordinance No. 0-11569 (New Series) provided that the CR Zone would attach if a final map or maps were recorded on or before May 24, 1977; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows: Section 1. That Section 1 of Ordinance No. 0-11569 (New Series), adopted April 24, 1975, amended by Ordinance No. 12105 (New Series), adopted July 20, 1977, and amended by Ordinance No. 12690 (New Series), adopted July 9, 1979 is hereby amended to read as follows:

Section 1. That in the event that Lot 2, Ocheltree Subdivision, Resubdivision of Lot 15; portions of Lots 12 and 13, Ocheltree Subdivision Unit 1; and a portion of Section 27, Township 18 South, Range 2 West, SBBM; and a portion of Outer Road to be vacated, in the

City of San Diego, California, within the boundary of the district designated "CR" on that certain Zone Map Drawing No. B-2847.2, is subdivided and a final subdivision map or maps thereof duly submitted to the City on or before May 24, 1983, and thereafter recorded, and within such subdivision or subdivisions provision is made for the installetion of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0421.1 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into CR Zone, as described by Section 101.0421.1 of the San Diego Municipal Code, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2847.2, filed in the office of the City Clerk as Document No. 758871. Said zoning shall attach only to those areas included in the subdivision map or maps recorded as provided in this section.

This ordinance shall take effect and be in force on the Section 2. thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
