AN ORDINANCE AMENDING THE PLANS FOR ABATEMENT OF A NUISANCE
ON CARMEL VALLEY ROAD.

BE IT ORDAINED, by the Council of The City of San Diego as follows:


Section 1. That the City Council hereby amends the plans approved pursuant to Ordinance No. 0-15512 (New Series) by the adoption of revised plans which will further reduce the wetland impact, a copy of said revised plans is on file in the office of the City Clerk as Document No. 00 - 15588.

Section 2. That section 2 of Ordinance 0-15512 (New Series) be amended to read as follows:

Section 2. The City Council hereby approves the plans for realigning Carmel Valley Road as presented and approved by the City Engineer as the appropriate means of abating the nuisance presented by the existing conditions, a copy of said plans is on file in the office of the City Clerk as Document No. 00 - 15588, including any revisions to said plans as the City Council may by Resolution and in accordance with the provisions of the San Diego City Charter and the San Diego Municipal Code approve.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
