ORDINANCE NUMBER 0- 15589 (New Series)
Adopted on SEP 2 9 1981

An Ordinance Incorporating a Portion of Rancho Los Penasquitos, and a Portion of Pompeii Farms Company, Pompeii Subdivision, Map No. 1738, (Approximately 113 Acres), Located on the East Side of I-15 Between Poway and Rancho Bernardo Roads, in the Rancho Carmel Community Plan Area, in the City of San Diego, California, into M-1B, M-L1 and CN Zones, as Defined by Sections 101.0435.2, 101.0434.1, and 101.0426 Respectively, of the San Diego Municipal Code, and Repealing Ordinance No. 8782 (New Series), adopted January 31, 1963, of the Ordinances of The City of San Diego Insofar as the Same Conflicts Herewith.

BE IT ORDAINED, by the Council of The City of San Diego as follows: Section 1. That in the event that within two years of the effective date of this ordinance a portion of Rancho Los Penasquitos, and a portion of Pompeii Farms Company, Pompeii Subdivision, Map No. 1738, (approximately 113 acres), located on the east side of I-15 between Poway and Rancho Bernardo Roads, in the Rancho Carmel Community Plan area, in the City of San Diego, California, designated "M-1B, M-L1 and CN" on Zone Map Drawing No. B-3426.1, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Sections 101.0435.2, 101.0434.1 and 101.0426 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into M-18, M-L1 and CN Zones, as described and defined by Sections 101.0435.2, 101.0434.1 and 101.0426 respectively, the boundary of such zones to be as indicated on Zone Map Drawing No. B-3426.1, filed in the office of the City Clerk as Document No. R-768274. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 8782, adopted January 31, 1963 be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
