AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 62.0207B, RELATING TO PUBLIC IMPROVEMENTS INCIDENTAL TO A BUILDING OR STRUCTURE.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Chapter VI, Article 2, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 62.0207 to read as follows:

SEC. 62.0207 PUBLIC IMPROVEMENTS INCIDENTAL TO A BUILDING OR STRUCTURE

A. (There is no amendment to this section.)

B. The provisions of this section shall not apply to the construction of accessory structures or neighborhood revitalization projects operated by the City Housing Commission and also shall not apply to construction of accessory buildings or alterations to existing buildings and structures where the proposed improvements have a total value, as estimated by the Building Official, of \$6,000 or less.

C. (There is no amendment to this section.)

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
