AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA REPEALING ORDINANCE NO. 0-15032 APPROVING A CERTAIN LEASE AGREEMENT BETWEEN THE CITY AND THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO, AND RESCINDING AND TERMINATING SAID LEASE AGREEMENT

WHEREAS, the Redevelopment Agency of the City of San Diego (the "Agency") is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Horton Plaza Redevelopment Project; and

WHEREAS, in order to carry out and implement such Redevelopment Plan the Agency has heretofore entered into that certain First Amended Disposition and Development Agreement (the "Agreement") with Ernest W. Hahn, Inc. (the "Developer") for the sale, lease and sublease of real properties in the Redevelopment Project for the development and construction of a major regional shopping center; and

WHEREAS, in order to carry out and implement the Agreement the City Council of the City of San Diego (the "City"), by Ordinance No. 0-15032, approved and authorized the execution of a certain "Lease Agreement" with the Agency, a copy of which Lease Agreement is on file in the office of the City Clerk as Document No. 00-15032, providing for the construction by the Agency and lease to the City of certain public parking facilities within the Horton Plaza Redevelopment Project area; and

WHEREAS, the Agency and City have approved that certain Second Amended Disposition and Development Agreement with the Developer pursuant to which the Developer, rather than the Agency and City, will plan, finance, construct and operate the parking facilities in connection with the major regional shopping center; and

WHEREAS, the Agency and City desire to rescind and terminate the Lease Agreement as it is no longer necessary to effectuate the Redevelopment Plan or the Agreement.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of San Diego as follows:

Section 1. Ordinance No. 0-15032 approving said Lease Agreement is hereby repealed.

Section 2. The Lease Agreement, Document No. \_\_\_\_, is hereby rescinded and terminated. The Agency and City shall have no further rights, obligations or liabilities to each other under the Lease Agreement.

Section 3. The City Clerk shall certify to the passage of this Ordinance by the City Council and cause the same to be published once in the official newspaper within fifteen (15) days after its adoption, and it shall take effect on the 31st day after its final passage.
