AN ORDINANCE AMENDING CHAPTER IX, ARTICLE 1 OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 91.02.0202 AND AMENDING SECTION 202(b) OF THE UNIFORM BUILDING CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IX, Article 1 of the San Diego Municipal Code be and it is hereby amended by adding Section 91.02.0202 to read as follows:

SEC. 91.02.0202 SECTION 202(b) OF THE UNIFORM BUILDING

CODE AMENDED

Section 202(b) Deputies. In accordance with prescribed procedures and with the approval of the appointing authority, the Building Official may appoint a chief plans examiner, a chief building inspector and other related technical officers and inspectors and other employees and representatives as shall be authorized from time to time.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
