AN ORDINANCE AMENDING ORDINANCE NO. 0-15552 (New SERIES), ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1981-82 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NOS. 00-15552-1 AND 00-15552-2, AS ADOPTED AND AMENDED THEREIN, BY APPROPRIATING AND TRANSFERRING THE SUM OF \$1,725,100 FROM THE UNAPPROPRIATED REVENUE OF THE SEWER REVENUE FUND (41506) TO THE WASTEWATER RESEARCH PROGRAM (70217), NON-PERSONAL EXPENSE; AND BY AMENDING SECTION 2, SUBSECTION 25 ENTITLED "SEWER REVENUE FUND" TO REFLECT SAID APPROPRIATION AND TRANSFER.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-15552 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1981-82 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby futher amended by amending Documents No. 00-15552-1 and 00-15552-2, as adopted and amended therein, by appropriating and transferring the sum of \$1,725,100 from the Unappropriated Revenue of the Sewer Revenue Fund (41506) to the Wastewater Research Program (70217), Non-personal Expense; and by amending Section 2, Subsection 25 entitled "SEWER REVENUE FUND" to reflect said appropriation and transfer.

Section 2. This ordinance is declared to take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of the City of San Diego.
