ORDINANCE NUMBER O- 15649 (New Series)

Adopted on JAN 18 1982

AN ORDINANCE INCORPORATING LOTS 2 AND 3 AND PORTIONS OF LOTS 6, 7, 8, 9 AND 10, HURD'S ADDITION, MAP 4444 (APPROXIMATELY .75 ACRES), LOCATED ON THE EAST SIDE OF FIFTH AVENUE, NORTH OF WASHINGTON STREET, IN THE UPTOWN MEDICAL COMPLEX PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C AND CO ZONES, AS DEFINED BY SECTION NOS. 101.0432.1 AND 101.0423, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12988, APPROVED OCTOBER 20, 1930, AND ORDINANCE NO. 190 (NEW SERIES), ADOPTED MARCH 27, 1933, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Lots 2 and 3 and portions of Lots 6, 7, 8, 9 and 10, Hurd's Addition, Map 4444 (approximately .75 acres), located on the east side of Fifth Avenue, north of Washington Street, in the Uptown Medical Complex Plan area, in the City of San Diego, California, within the boundary of the district designated "C" and "CO" Zones on Zone Map Drawing No. B-3481, be, and it is hereby incorporated into C and CO Zones, as such zones are described and defined by Section Nos. 101.0432.1 and 101.0423, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 12988, approved October 20, 1930, and Ordinance No. 190 (New Series), adopted March 27, 1933, of the ordinances of The City of San Diego be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no

building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
