The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that that certain easement with the right of ingress and egress for the construction and maintenance of sewer facilities, as granted and shown on this map, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.
