BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those easement deeds of HOME SAVINGS AND LOAN ASSOCIATION, a California corporation, bearing date of August 7, 1980, copies of which deeds are on file in the office of the City Clerk as Documents No. RL- 253360-1 and RL- 253360-2, granting to the City easements for drains, sewers and public street purposes over, under, along and across all those portions of Sections 2 and 3, Township 15 South, Range 2 West, San Bernardino Meridian, as more particularly described in those deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named RUE CHANTEMERE.

That the City Clerk is hereby authorized and directed to cause said deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
